

# Visiting Fellows Scheme

Visiting (Senior) Fellow appointments are intended to help Departments, Institutes and Centres to invite staff who are either practitioners or academics in other institutions to conduct research, or be involved in other activities which will benefit the Department.

You will have free access to use the Library and other LSE resources. No fee is payable to LSE. No salary is paid by the School for these appointments.

If you have not yet completed your PhD, please refer to the Visiting Research Students scheme.

## Department of International Development Visiting Fellows

The **Visiting Fellow** category is our standard scheme for academic visitors or visiting non-academic professionals.

## Department of International Development Visiting Senior Fellows

The **Visiting Senior Fellow** category is for academic visitors who have already published work of distinction, or visiting non-academic professionals at a broadly comparable level in their profession. In addition, academic candidates must be at least at the Lecturer (post-major review equivalent), Senior Lecturer, Reader or Associate Professor Level at their home institution.

### Please note the following:

1. Proposals will be circulated to the Department of International Development academic staff and are then considered at School level four times each year, the deadline dates for submitting your proposal are shown [here](#). Completed applications must reach the International Development Department Manager no later than 2 weeks in advance of each deadline for submissions to HR for it to be considered at the next submission. You should receive a final response within eight weeks of these dates.
2. As a Visiting Fellow you will be matched with one of our academic staff who can mentor you during your stay here. There is a limit to the number of visitors we can accommodate each year and we can only confer the title of Visiting Fellow if we have academic staff who are both researching in your area *and* available to mentor during the dates of your proposed visit.
3. Please refer to the **LSE term dates** and note that most scheduled teaching takes place in Michaelmas and Lent Term, and that most **public events** take place in the Michaelmas, Lent and Summer Terms.
4. While we are not able to provide you with an office, Visiting Fellows can sometimes be offered desk space. You would have access to the LSE Library, with full borrowing rights and access to the computers and printers in the Library and elsewhere around the School.
5. LSE has no residential accommodation which would be available to Visiting Fellows.
6. Visiting Fellows from many countries outside the EU who receive financial support of any kind from a formal source of funding such as government, university, research council, charitable organisation etc., to carry out research, will be required to have a Sponsored Research Work Permit to work at the School. You must ensure that you obtain the correct work permit or visa before you commence your visit.
7. Conditions of acceptance are that you will:
  - (a) submit a working paper (6,000-10,000 words) to the Department of International Development, to be published subject to acceptance, before the completion of your visit or within one month of your departure, and;
  - (b) be available to deliver a research seminar to our staff and PhD students (subject to term dates and other factors) if requested.
