Dear Student

I am writing to give you a little more information about the start of your MSc programme at LSE. The programme you are joining in September, the MSc in Global Economic History (Erasmus Mundus), offered as part of the twoyear MA Global Studies programme, offers you an ample choice of courses spanning qualitative and quantitative approaches to history, taught by committed teachers who are leading experts in their fields. I have no doubt that this year's programme will be a great success, as this and previous year's programmes have been.

PROGRAMME REGISTRATION AND DEPARTMENT MEETINGS:

Term begins on Thursday 26th September and teaching on the programme begins on Monday 30th September. But we have a number of important events and meetings in the days before term begins. We will also write to you with details of the programme and department induction meetings as soon as they are finalised.

COURSE CHOICES

We are currently finalizing the range of courses that will run next year to ensure you have access to a broad and interesting syllabus. As you will appreciate, the exact range of courses offered each year varies: some courses have to be suspended because the faculty are on research leave, while new courses are introduced to reflect changing research interests and new appointments. Please check our website <u>MSc Global Economic History</u> for the most up-to-date course list. Be aware, though, that this list remains provisional and occasionally a course may be withdrawn at a later stage.

You do not need to apply for specific courses until after you arrive. Course choices will be made via our online systems, but please *do not* attempt to register for courses until you have attended the induction events and been to a class to get a sense of whether this is the right option for you. We strongly recommend that you consult with your mentor before making your choices. You will have until the **end of Week 1** to decide.

Please note that although we do everything we can to ensure that all students receive a place on their preferred options, sometimes unexpected peaks in demand and teaching and timetabling constraints prevent us from accepting every student who applies for a specific course. To help us in these situations, when you request a place you will be asked to complete a <u>statement of intent</u> in the online application system. Use this to outline why you want to take a particular course. You will also be asked to <u>rank your choices</u> to enable us to offer places accordingly.

ACADEMIC MENTORS:

Upon arrival, you will be assigned an academic mentor from among the Economic History staff. This person will be your first contact and personal tutor throughout the year, and will direct your MSc thesis. Your mentor will also assist you in getting expert advice from other staff members whenever appropriate. To assist us in making the best match, we will be asking for you to give as an <u>indication of the areas you are interested in during the summer</u>. Please ensure you respond to that message, so that we can find you the best supervisor.
