

## Professor Julian Le Grand

Professor Julian Le Grand is the Richard Titmuss Professor of Social Policy at the London School of Economics. From 2003 to 2005 he was seconded to No. 10 Downing Street as Senior Policy Adviser to the then Prime Minister, Tony Blair. He is currently part-time adviser to the President of the European Commission. He has also acted as an adviser to the World Bank, the World Health Organisation, the OECD, HM Treasury, the UK Department of Health and the BBC.

Professor Le Grand is a well known scholar who has used his intellectual skills for effective policy making. He is the principal architect of many of the current British Government's public service reforms. In his academic role, he has written nineteen books, more than one hundred refereed journal articles and book chapters on economics, philosophy and public policy. Among other honours, he is one of Prospect magazine's 100 top British public intellectuals, a founding academician of the Academy of Social Sciences and an Honorary Member of the Faculty of Public Health.
