INTERVIEW WITH ACCOUNTING ALUMNI ETHAN ROBERTSON

MSC ACCOUNTING, ORGANISATION AND INSTITUTIONS (AOI) 2023
NATIONALITY: BRITISH



Thank you for joining us. Can you tell us a little more about yourself and what subject you studied before joining LSE?

My name is Ethan, and I am 22. I studied International Business Management before joining LSE which was very enjoyable and equipped me with broad international business awareness, but not advanced accounting knowledge. I completed a dissertation in my final year underpinned by the 'AOI Literature' which smoothed the transition into the intellectually challenging Accounting, Organisations and Institutions (AOI, AC424) course.

What drew you to LSE?

LSE is an internationally renowned institution, and the quality and challenge of the studies reflects this. AOI is unique as the programme tests you to take accounting away from its purely technical form by drawing on a broad range of social science schools of thought. This attracts students from a variety of undergraduate degrees and fosters a great environment for collaboration in lectures and group projects. Students can also take electives in a large variety of modules from departments across LSE; the only difficulty here is too much choice so research beforehand what interests you.

The LSE is centred in the heart of London which gives you excellent access to the London job market. Many students at LSE are interested in pursuing careers in financial services and the department staff and careers services are always there to help in guide and support you at any point in the application process. Lastly one great thing about LSE is the diversity. During my time so far, I have been able to meet and make friends from all over the world.

What has been a highlight of your time at LSE and with the Department so far? The Cambridge Graduate weekend was my highlight. Three coaches full of Accounting students travelled to Cambridge for two days and we had team building games, guided tours, gondola rides and a night out with fellow classmates and faculty. Also the AOI Society quiz, at George IV, the foremost society and group at LSE!



What is your favourite module and why?

I have enjoyed all the courses so far. But I can give my top three which would be:

- 1. Corporate Financial Disclosure and Investor Relations (AC417)
 We studied in detail the key players and interactions between the core capital market players (and some game theory).
- 2. Accounting Organisations and Institutions (AC424) This is the AOI core course which isn't available as an outside option to students on other courses. This results in a close bond in the class and enjoyable class discussions.
- 3. Security and Valuation Analysis (AC444) This is one of the more technical courses and I have enjoyed the group project where we are placed as a sell-side analyst to create an equity research report on a corporation of our choice.

What's a typical day like on the programme?

A typical day on the programme usually involves preparation for in class case discussions, formative assessments, background reading and one or two lectures a day. In my free time I usually explore London, meet with friends and take part in societies - for which there are plenty of societies to choose from; see LSE SU webpage.

What activities have you been involved with at LSE in addition to your studies?

- 1. AOI society!
- 2. Student Academic Rep This is a great opportunity to meet with faculty and be the voice of the students regarding any concerns that could be resolved or positives in the programme that should continue for next year's programme (e.g. the Cambridge trip).
- 3. Squash Club
- 4. Rugby Club

What's your advice for someone wanting to study the same programme?

I would say make sure to do your research and understand why AOI specifically is something you are interested in because the work is intellectually challenging and if you are interested in the literature your experience will be all the more rewarding. A good starting point is to take a look at the preliminary reading by C S Chapman, D J Cooper and P Miller (eds.) Accounting, Organizations and Institutions (Oxford University Press, 2012) and journals Accounting Organisations and Society and Critical Perspectives on Accounting.

If you are interested in working in the U.K (or elsewhere) I would also recommend that over summer, you plan the applications that you wish to make when they open (many jobs open within the first month). Applications can be very time consuming, and the course is demanding so this will put you in a good position in Autumn Term.
