## Your Offer: meeting your conditions

It is vital that you fully read the [Graduate Offer Pack](#), which outlines the various steps that you must take before registration. Read **fulfilling conditions attached to your offer & supplying required documents** on page 13. For international students, also read page 17 **visa advice for international students**.

Any outstanding conditions and documents are displayed in your [LSE for You](#) account; be sure to submit these in good time. You will not be allowed to register unless you have submitted all documentation specified on your offer of admission *and* all the legal documents (e.g. appropriate ID; Visa (if applicable)) necessary for registration. Any documentation regarding your offer should be sent to the [Graduate Admissions Office](#) as early as possible.

MSc EME students are required to attend EC451 Introductory Courses for MSc EME students. In order to attend this course, you must be registered on your programme on **28 August 2019** before EC451 commences. If you think you are unlikely to meet this date due to unavoidable reasons, contact our [MSc Programme Manager](#) as soon as possible.
