### **Call for Papers**

#### **Background**

Over the last two decades the countries of South Eastern Europe (SEE) have been undergoing lengthy structural reforms as a consequence of the combined processes of economic transition, social change, administrative reform, post-conflict reconstruction, state-building and preparations for accession to the EU. Educational reform is of critical importance in the context of these transformative changes. Yet the education systems in these countries have remained largely unreformed since the collapse of the former socialist systems.

The education systems in the Western Balkans are among the most selective system in Europe with a clear division between secondary ‘grammar’ and vocational schools. They therefore provide a strong testing ground for the impact of selection and school experience on social exclusion. This workshop is intended to contribute to these debates by identifying the nature and extent of exclusion in vocational schools in the enlargement countries, the causes of such exclusion and present evidence-based policy proposals for improvement in the educational policy and practice.

#### **Aims**

The workshop aims to provide a forum for the presentation, dissemination and discussion of the latest research on vocational education and training and inclusive education in the Western Balkans among researchers and key stakeholders. After the workshop the papers which will be submitted for

publication as a special journal issue. Researchers are invited to submit abstracts of their papers **by May 5, 2014**.
