Despite the pandemic, we recruited 27 students for the 2021/22 cohort. Students came from 13 different countries and a wide range of employment backgrounds across corporate, non-profit and government sectors, including organisations such as Bloomberg L.P, Accenture, Waze-Google, International Committee of the Red Cross, The Food and Agriculture Organization of the UN, Sunderland City Council, Cayman Islands Government, and One Young World.



Teaching was delivered in a hybrid format and we were pleased that most of the class were able to make it to campus with some joining online due to COVID restrictions. 

# Master's in Public Administration Social Impact stream

In 2021 Lent Term the Institute once again provided teaching for the MPA Social Impact Policy Stream. 

# Online Certificate Course, 'Social Entrepreneurship: Creating Your Impact'

The Institute spent the early part of 2021 developing content for a new online certificate course 'Social Entrepreneurship: Creating Your Impact'. The team worked with in collaboration with the LSE's Extended Education team as well as a dedicated development team from GetSmarter, an online education provider. The first presentation of the course ran from 3 October 2021 for 9 weeks. The first cohort attracted 43 students from across the world, amongst them were founders and entrepreneurs, students working in the public sector and private sector including finance, engineering and media and advertising.



This year, **Professor Julian Le Grand** and **Dr Jonathan Roberts** have published their research into ethical consumerism: 'Buying for good: altruism, ethical consumerism and social policy' (with Gauri Chandra) Social Policy & Administration (2021) 55 DOI: <a href="http://dx.doi.org/10.1111/spol.12729">http://dx.doi.org/10.1111/spol.12729</a>.

They have also developed their work on hybrid organisations through:

- The article 'Hands, hearts and hybrids: economic organisation, individual motivation and public benefit' in the LSE Public Policy Review. (2021) 1(3). DOI: <a href="https://ppr.lse.ac.uk/articles/10.31389/lseppr.20/">https://ppr.lse.ac.uk/articles/10.31389/lseppr.20/</a>
- A new research agenda focused on Match Trading, an innovation in grant funding designed to support the sustainability of social trading organisations. The project has been developed with the School for Social Entrepreneurs (SSE), and will run for at least the next two years, with the aim of expanding on the current understanding of the grant making mechanism and its contribution to sustainable social impact.

Jonathan Roberts has in addition published an article called 'Social Entrepreneurship and Entrepreneurial Philanthropy: Their Contribution to a 'What Works' System in the Homelessness Field' in the European Journal of Homelessness 2021 15(3). <a href="https://www.feantsaresearch.org/en/publications/european-journal-of-homelessness">https://www.feantsaresearch.org/en/publications/european-journal-of-homelessness</a>

The Altruistic Capital Lab (ACL), under the leadership of **Professor Nava Ashraf** continued to conduct frontier scientific research, using a co-generation of knowledge model, together with public and private sector organisations who can scale the findings. The ACL's work now spans six academic studies with two of the world's largest multinational companies.

Recent developments include:

 A working paper on The Misallocation of Women's Talent, leveraging data from the same global consumer goods company from 114 countries as well as multiple other sources of data, shows that increasing female

- labour force participation would lead to significant productivity gains in almost every country studied, with an average of 32% increase in economic productivity.
- A 95k grant from Nuffield foundation to support an
  innovative study which combines reflective workshops
  with the opportunity to create a new sense of purpose
  through community volunteering. As part of this project,
  an impressive advisory group, including global Trade
  Union leaders, industrial relations experts, leading
  academics and members of the UK government's
  Levelling Up Commission, who can integrate the
  findings throughout the process into policy.
- The publication "Losing Prosociality in the Quest for Talent? Sorting, Selection, and Productivity in the Delivery of Public Services" published in the American Economic Review (Ashraf, Bandiera, Davenport and Lee, May 2020) in 2021 was awarded the Kenneth J. Arrow Award, for the best health economics paper worldwide, by the International Health Economics Association. The intervention evaluated in the paper, co-designed with the authors and the Zambian government, is now instilled as the World Health Organisation's recognised gold standard for Community Health Workers.
- An early working paper "Learning to see a World of Opportunities" was presented at the Behavioural Economics Annual Meeting in May 2021 and further results from a follow-up intervention will complement this in 2022.
- A working paper "Learning to Teach by Learning to Learn", co-authored with Vesall Nourani and Nobel Prize winning economist Abhijit Banerjee, was presented at the Virtual Development Economics Seminar (VDEV), and describes results from a teacher training program, implemented in Uganda, which led to one of the largest transitions to secondary school (from 50% to 75%), and second-most cost-effective intervention, ever seen in the global education literature.

The Marshall Institute continued to facilitate exchange between the key actors in the field of private action for public benefit.

# **The Marshall Impact Accelerator**

On 3rd November 2021, the Institute was delighted to announce the donation of £50M from Sir Paul Marshall to launch a social impact accelerator to develop innovative solutions to the world's most pressing challenges. The accelerator will be a unique new launching ground for innovative social ventures, providing grants through philanthropic capital.






# **Philanthropy Bites – Podcast Series**


