

Released this week

New report: Final recommendations for policy

- Brings together all EU Kids Online policy guidance and evidence-based recommendations in a single resource for policymakers.
- Outlines over 30 actions that children and young people, parents, educators, governments, awarenessraising and the media, as well as industry providers can take to make the internet a better and safer place for children.
- Advocates a proportionate, balanced and multistakeholder response to risks and challenges that young people face online, while promoting positive content, children's digital rights and promotion of digital opportunities for all European young people.

This report has been released in time for the <u>Internet</u> Governance Forum 2014, where EU Kids Online will:


- Host a <u>panel</u> on Researching children's rights in a global, digital age, and;

Report: Meaning of online problematic situations: results
of a qualitative investigation in nine European countries.

sensationalist media. The report reveals a diverse set of

ways in which children try to cope with online risk of harm.

- Report on children's online experiences in socially disadvantaged families: shows that children of lower educated parents are often left alone when dealing with the internet.
- Presentation to the CEO Coalition, Brussels, comparing survey findings from 2010 to 2014

 This report reveals a divide between parts of Europe that enjoy better or lesser public support for internet safety.
