



The Marshall Institute Scholarship

The Executive MSc Social Business and Entrepreneurship aims to ensure outstanding candidates from a wide variety of backgrounds are able to participate in the programme, even if they are without the means to meet the full costs of their study.

For 2019/20 Executive MSc Social Business and Entrepreneurship applicants, the Marshall Institute is delighted to introduce a **scholarship scheme** offering partial tuition fees support to outstanding candidates. This scheme is open to all applicants who are unable to meet the full cost of tuition, regardless of nationality, current residence or professional background.

As only a limited number of awards are available, the Marshall Institute uses a selection process that considers both the quality of the applicant and their financial need. The former will be judged on the information provided in the programme application (submitted through Graduate Admissions) and the latter will be assessed according to information provided in the Executive MSc Social Business and Entrepreneurship Scholarship Application Form.

The deadline to complete the scholarship application process is Monday 3rd June 2019. Full details of the application process are outlined below. Applicants must complete all steps by the deadline in order to be considered for a scholarship. The Marshall Institute aims to announce all scholarship decisions by July 2019.

Selection

As scholarship funding is limited, the selection panel will allocate awards according to a variety of factors, including the quality of applicants and their financial need. Applicant quality will be assessed using information from their Executive MSc Social Business and Entrepreneurship programme application. Financial need will be evaluated using information provided on the scholarship application form.

Please note that successful candidates may be asked to provide proof of their financial need, such as payslips or bank statements.

The selectors will review all applications and **may** choose to conduct interviews in June/July, via telephone or Skype.

We aim to announce scholarship decisions by July 2019. All scholarship decisions are final and no appeals are possible.



How to apply

In order to be considered for a scholarship, applicants must complete **BOTH** of the following steps **by Monday 3rd June 2019**.

Step 1: Programme application

Step 2: Scholarship Applications

Submit a scholarship application using the Executive MSc Social Business and Entrepreneurship [Scholarship Application Form](#).

To assist in completing the form, please see the below list of information that applicants should collect in advance (please note that all financial amounts should be in GBP):

- Expected net (after tax) income from September 2018 to August 2019 in GBP
- Expected net (after tax) income from September 2019 to August 2020 in GBP
- Details of expected financial contributions towards your studies (including the source of the contribution and the amount they are able to contribute in GBP)
- Details of other forms of financial support you have applied for or have secured, for example loans or other scholarships (including the source of the support, and the expected/secured amount in GBP)
- Any additional information that you believe is relevant to your application that is not included in the scholarship form or your programme application.
