FUNDING AND FINANCIAL SUPPORT

LSE makes available over £12 million annually in financial support for its students via a range of scholarships, bursaries and award schemes.

Taught master's funding

There are a range of awards available for study at this level. The value of support can range in value from 10% of the tuition fee, to a full fees and maintenance award.

Support is available for the majority of programmes through the <u>Graduate Support Scheme (GSS)</u>, <u>country-based awards</u>, and <u>programme-based</u> awards.

You can apply for funding via the Graduate Support Scheme through your <u>LSE for You (LFY)</u> account – you only need to apply once to be considered for all awards except for some country/programme based awards, please do check the links above for full details of each award.

If you are unsuccessful in obtaining GSS funding, your details will be kept on file for consideration for any other awards being offered by LSE, for which you may be eligible.

Refugee Scholarships

For 2017/18 entry LSE plans to award up to ten full scholarships for applicants with refugee status on any MSc programme

Applicants will be considered via the LSE Graduate Support Scheme application. More information on the Refugee Scholarships can be found here.

External funding

There are also many <u>external organisations</u> that may be able to offer you funding to support your graduate studies, and we recommend that you explore as many options as possible.

Make sure you check the terms and conditions of any scholarship before you accept it. If you require any additional proof of your offer when applying for a scholarship, please complete this form and we will be happy to provide this for you.

PHD FUNDING

Your academic department will nominate a limited number of candidates to be considered for one of 64 <u>LSE studentships</u>.

These awards cover fees and £18,000 living expenses for four years.

The final decision is made by a School awards panel, and there is no additional application you need to make.

Although the main deadline has now passed to apply for PhD funding, <u>some programmes</u> are still accepting applications for funding.

TUITION FEES

Your tuition fees will be detailed on your official offer letter.

You can choose to pay your fees in instalments; if you choose to do so the first instalment of at least 34% will be due on, or before, the 28th September 2017.

You can pay all or part of your fees ahead of registration if you wish. The payment link is found in your <u>LSE for You</u> account.


Electoral shocks usher in a wave of 'intense voter hostility'
