

LSE Widening Participation and your data: overview statement Year 9 and above

Why do you collect my data, and how will you use it?

The LSE Widening Participation team collects data about participants on our projects to help us target our work, run our projects safely, evaluate the impact of our projects and track long-term outcomes of the young people we work with.

We'll analyse data from everyone who participated in our projects and publish reports based on this data. It will never be possible to identify individuals, including you, in these reports.

For evaluation purposes only, we might share some data about you with public bodies such as national statistics organisations like the Higher Education Statistics Agency or university sector bodies like UCAS or the Higher Education Access Tracker (HEAT). We might also share it with our undergraduate admissions team at LSE so they know that you've worked with us if you choose to make an application to LSE.

Any data you've previously shared with the LSE Widening Participation Team will also be covered by these conditions from now on.

How will you store and protect my data?

Your data will be safely held on a secure database in compliance with the Data Protection Act and the General Data Protection Regulations. We'll keep your data until you're 27 years old, so that we can evaluate the long-term impact of our projects, and then delete any identifying information.

What if I don't want to share my data?
