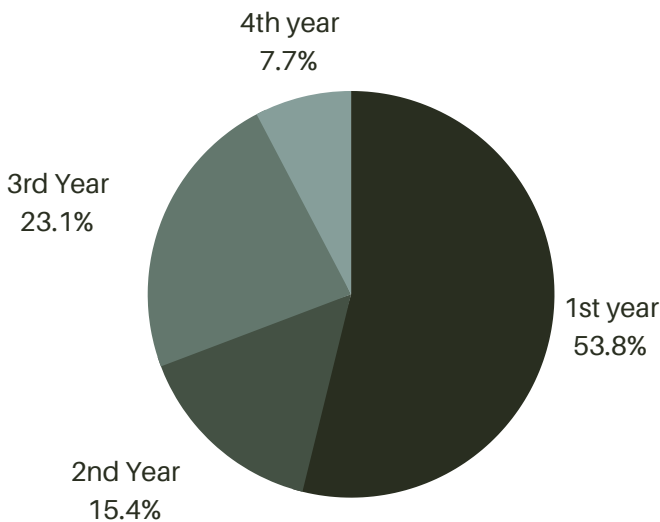
# PhD Summer Research Grants 2019-2020

# 2019-2020 PhD Summer Grant Recipients

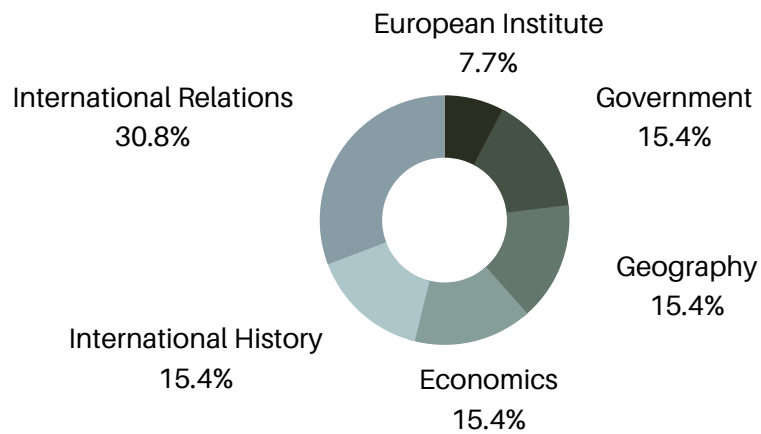

In 2019-20, the Centre received 13 applications from different departments at LSE, which was a 30% increase compared to the previous year.
