‘Reexamine the Restoration: Fiscal Capacity and Industrialization in Modern China, 1860s-1930s’ (Ready for Submission to *Journal of Economic History*)

This article contributes to the Great Divergence debate by providing an institutional narrative on the onset of China’s industrialization. It constructs a novel dataset, employs the Taiping Rebellion as an instrument variable and finds that the autonomous local fiscal capacity led to the pervasive and persistent local industrialization.

‘The Merit of Misfortune: Taiping Rebellion and the Rise of Indirect Taxation in Late Imperial China, 1850s-1900s’ (Ready for Submission to *The Economic Journal*)

This article revisits the role of war in state development but goes beyond the scope of Western European nation states. It offers fresh views on the positive relationship between indigenous political disorder and fiscal capacity (in commercial taxation) by studying an influential Late Qing rebellion with an original dataset.

‘Fiscal Decentralization, Historical Legacy and Economic Performance: Empirical Evidence from Coastal Prefectures in China, 2010-2015’

This article studies the effect of fiscal decentralization on economic growth, one of key empirical issues on fiscal federalism. It establishes a panel dataset and considers historical linguistic and social division as an instrumental variable for today’s degree of fiscal decentralization, as the first attempt to overcome endogeneity in the literature.
