Organisers' welcome

Dear students, colleagues, alumni and friends of LSE,

We are delighted to welcome you to *Knowledge Beyond Boundaries*, the third annual interdisciplinary student research conference happening this year as part of the LSE Festival. This conference was designed as an open, welcoming and inclusive space for students and recent alumni of LSE to engage in interdisciplinary dialogue, debate the big questions of social science, and collaborate with others from outside their own discipline. The conference is an opportunity for participants to empower their academic, personal, and professional growth while showcasing their research for the LSE community and beyond.

In organising today's programme, our aim was to bring a diverse set of student and alumni voices into conversation about some of the most pressing challenges of our time, and to provide a space for participants to deepen their knowledge, question previously held assumptions, and learn from each other. We were excited to receive over 80 proposals to present at the conference, including papers, posters, creative show-and-tell projects and performances. The projects range from first-year undergraduate student research to in-progress MSc dissertations, from collaborative research teams to work from recently graduated LSE alumni. We are especially delighted this year to welcome nearly 20 participants from our CIVICA partner universities across Europe, many of whom have travelled to London to be here with us in-person for the conference.

This year, our conference focus aligns with the theme of the LSE Festival: people and change. *How do people effect change, and how does change affect people?* Today's panels focus on a cross-cutting set of themes including the future of education, the impacts of displacement and war, changing global business and economic landscapes, and the effects of living in a digital age – all with the goal of interdisciplinary conversation about how we shape the world.

As interdisciplinary educators and academics, we are enthusiastic proponents of stepping beyond the boundaries of your degree programme as a student – the skills you need to tackle complex problems can't all be found within the confines of a single discipline. Whether it's learning how competing definitions shape a challenge, understanding why methodological choices matter, or interrogating the borders of disciplines themselves, we hope this conference sparks your curiosity and broadens your understandings of what student-led social science research looks like.

We are grateful to everyone who has made today's conference possible, including the generous donor support from the LSE Student Futures initiative, Professor Emma McCoy for her closing plenary remarks, Dr Claire Gordon and the Eden Centre team, Louise Jones and the LSE Festival team, Abi Black and Clara Rawlings as well as the Communications Division, Helen Rosemont and the CIVICA team, the LSE100 Fellows acting as research mentors and conference chairs/ discussants, and our amazing student ambassadors.
