Abstract: This workshop on divorce and its aftermath in contemporary Asia is based on a forthcoming edited volume. Rapid socio-economic changes across Asia, along with the unremitting emphasis on strong family values, make the Asian region an illuminating case study for research on divorce and intimacy. Across differences of class, ethnicity and race, and community, our volume seeks to examine post-divorce trajectories. Can the lived experience of divorce be a porthole, in the sense of a break with the past, a gateway between two worlds; or does it augment stark inequalities that are historically rooted? What can divorce signal about family formations, societal transformations, age and identity in globalizing Asia? Our papers will explore how former spouses - including heterosexual and queer subjects, reconfigure themselves in relation to one another, and remap a whole set of other intimate relationships, to rebuild their lives after divorce.
