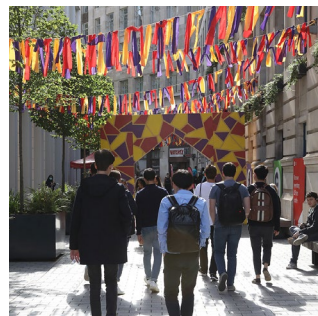

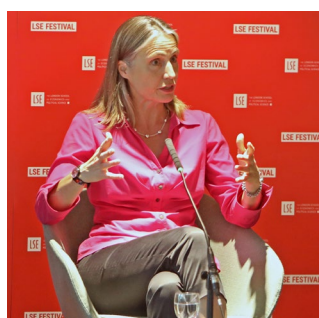

Director's Message

I write at a moment of geopolitical upheaval and political fragmentation. Vladimir Putin's invasion of Ukraine has upended assumptions and norms about the international order that have prevailed since the end of the Cold War. It has also underscored the importance of US international engagement after a period of erratic, uncertain American leadership. At a time when America is deeply divided at home, the stakes could not be higher, and the need for clear-eyed, independent analysis could not be greater.

The Phelan United States Centre is devoted to providing policy-relevant analysis and commentary in these complex times. This year we have launched several important new initiatives, including a multi-year speaker series on the future of US-China relations, a seminar series on the role of race and gender in American politics, and collaborative international conferences on the future of the liberal international order with Georgetown University,

Princeton University and the European University Institute.

With the generous support of the Phelan Family Foundation, we are running more events for academics, students and alumni around the world than ever before. We are drawing in ever-larger audiences through our popular blog, podcasts, and digital engagement on American politics and society. Much of our programming this year was necessarily online due to COVID-19, but we are pleased to now be welcoming people back in person.

As the Centre's global reach has increased, its presence at the School has also expanded. We have welcomed new LSE faculty affiliates, increased opportunities for visiting faculty, postdoctoral fellows and PhD students, and added new members of staff. Our undergraduate research assistantship programme continues to set the pace at the School, attracting huge numbers of undergraduates. New initiatives for master's students are in the works as well.

As Director, I have the good fortune of working alongside a team of talented and dedicated individuals who do so much in so many ways to make the Centre's promise a reality. Despite the challenges COVID-19 presented again this past year, the Centre did not lose a beat. We continued to deliver on our core mission through research-led seminars, faculty workshops, public engagement and student internships and grants.

As we look forward to next year, I want to thank everyone – from our faculty affiliates to professional staff to our students and alumni – who help to make the Phelan United States Centre such a vibrant, inclusive intellectual community.

About the Director

Peter Trubowitz is Professor of International Relations at LSE and Associate Fellow at Chatham House, the Royal Institute of International Affairs. His main teaching and research interests are in the fields of international security and foreign policy, with special focus on the United States. He has written widely about the ways domestic politics have shaped America's approach to the world since its founding, and about how geopolitics, globalisation and other international forces have influenced and shaped American political development and contemporary US politics.

Professor Trubowitz's scholarly publications include *Politics and Strategy: partisan ambition and American statecraft* (Princeton University Press) and the prize-winning *Defining the National Interest: conflict and change in American foreign policy* (University of Chicago Press), as well as articles in scholarly journals such as *International Security*, *International Studies Quarterly* and *Perspectives on Politics* and more popular titles including *Foreign Affairs*, *International Herald Tribune* and *The National Interest*. His newest book, *Geopolitics*

and Democracy: the Western liberal order from foundation to fracture, is forthcoming with Oxford University Press.

An award-winning teacher, Professor Trubowitz has lectured on international affairs at universities worldwide as well as to government bodies, think-tanks and private companies. A frequent television guest on CNBC, BBC, Bloomberg and other major international media outlets, he has undertaken research supported by grants and fellowships from the John D. and Catherine T. MacArthur Foundation, the John M. Olin Foundation, the Ford Foundation and the Social Science Research Council, among others.

Before joining LSE, Professor Trubowitz was Professor of Government at the University of Texas at Austin. He has also held visiting academic positions at Harvard University, Princeton University, the University of California at San Diego, Universidad de Chile, Centro de Investigación y Docencia Económicas (CIDE) in Mexico City, and Beijing Foreign Studies University, where he was the J. William Fulbright Distinguished Lecturer in American Foreign Policy.

Rethinking the 1990s: liberal world order-building in the post-Cold War era 9 to 11 June 2022

The 1990s were a high-water mark for the West's confidence in itself. Many commentators viewed the collapse of the Soviet Union and communism in Eastern Europe as a victory for liberalism and open economies. The end of the Cold War, they argued, represented the permanent victory of liberal democracy and capitalism over the forces of illiberalism and nationalism. Today, those Western visions of the future look dated and off-target. If Western prognosticators significantly underestimated the staying power of autocracy and statist economies, then they also greatly overestimated the extent to which Western publics would back their governments' efforts to globalise the liberal franchise.

EUI, Georgetown and LSE Conference

Held on 13 and 14 May 2022 at the Robert Schuman Centre for Advanced Studies at the European University Institute in Fiesole, Italy, the conference was a joint venture between the Robert Schuman Centre at EUI, Georgetown University, and the Phelan US Centre at LSE.

The **Geopolitics in the Age of Populism: the future of the liberal order** conference brought together a group of leading scholars, practitioners and analysts to discuss these and related questions.

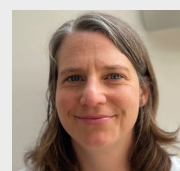

Centre Affiliate Spotlight

The Phelan US Centre provides funding for faculty affiliates organising small conferences on US-related research topics or themes. These conferences are designed to bring together up to a dozen scholars from the US, Europe and LSE to present and discuss ongoing research. Such efforts often culminate in research outputs such as journal articles.

As part of this initiative, in May 2021 Dr Amanda Sheely, Associate Professor in LSE's Department of Social Policy, organised the **LSE Single-Parent Family Conference**. Conducted virtually over three days, the conference included academics based in the UK, Sweden, Germany, Belgium, Italy, Finland and the United States. This conference opened with an LSE public event on 20 May 2021, co-hosted by the Department of Social Policy and the Phelan US Centre: *Where Are All the "Welfare Queens"? Diversity and European evidence*

on single-parent families.

Dr Sheely's conference resulted in a special issue on single-parent families published in July 2022 in *The ANNALS of the American Academy of Political and Social Science*, a video entitled 'Effective policy for single-parent families in the US: The importance of considering international evidence', and commentary summarising the research findings on the Centre's daily blog. An article in LSE's *Research for the World* online magazine linked to the special journal article and video.

Race, Gender and Politics in the US Seminar Series

In Michaelmas Term 2021, the Phelan US Centre and LSE's Department of International History hosted a new interdisciplinary seminar series bringing together historians, political scientists and sociologists to share current research on the theme of race, gender and politics in the US.

Given the rise of the global Black Lives Matter movement against a backdrop of burgeoning white nationalism, sexism and police brutality, scholars reflected on the longer arc of these issues historically and how they are shaping the present moment.

Digital Content Innovation

In 2021-22, our digital platforms continued to support the Phelan US Centre's mission to promote empirically grounded and policy-relevant scholarship on the US and its changing role in the world. Both our daily blog, USA Politics and Policy (USAPP), and our regular podcast series, The Ballpark, have hosted research-based insights and commentary on current US issues from a diverse range of academics, policymakers and activists, and have continued to connect with a growing global audience.

USA Politics and Policy (USAPP) blog

About LSE USAPP

This year, the Phelan US Centre's regular blog, **USA Politics and Policy (USAPP)**, has continued to present a wide range of research summaries and evidence-based commentary relevant to the United States and its changing role in the world. The blog's aim is to make social science research on topics from COVID-19 to political polarisation relevant by translating it for a wide audience including policymakers, students, activists and other interest groups. With over 1,000,000 pageviews and 150 original posts in 2021-22, the USAPP blog has continued to be a venue for researchers, academics, policymakers and activists to promote their work and thinking in an accessible way to an international audience.

During 2021-22 USAPP has hosted several blog series: What Happened? (covering the 2020 presidential election results), The 2022 Midterms,

Religion in American Society (in collaboration with LSE's Religion and Global Society Unit), and Building Back Better (which looks at President Biden's economic and social agenda). The USAPP team are also developing a new blog series covering climate change in the US.

Reach and Impact

■ The USAPP blog platform has continued to be an influential and respected source for evidence-based commentary that informs discussion and debate in the US and internationally. In 2021-22, articles published on USAPP were mentioned in media outlets including *The New York Times*, *Forbes* and *Bloomberg Opinion*. We are also aware of elected officials and political parties in North Carolina, Wisconsin and Newfoundland, Canada using USAPP as a resource.

The Ballpark podcast

About The Ballpark

The Ballpark podcast is the Phelan US Centre's regular audio series which explains current issues in US politics, policy and society to a wide, non-academic audience through interviews with expert commentators. During 2021-22, the Phelan US Centre has continued to produce and release episodes of The Ballpark, including a relaunched State of the States series. This series features magazine-style podcasts that take an in-depth look at politics and policy issues in specific US states. This series has included episodes covering California, New York, Mississippi (featuring Centre Affiliate Dr Johann Koehler), Colorado and North Dakota.

We have also continued to release Extra Innings episodes featuring interviews with academics and policy practitioners. Guest interviewees in 2021-22 have included Centre

Affiliates including Professor Mick Cox of LSE IDEAS, and other high-profile academics and practitioners, such as Professor Robert Lieberman of Johns Hopkins University, Professor Suzanne Mettler of Cornell University and Dr Fiona Hill of the Brookings Institution.

The Ballpark podcast works in tandem with the Phelan US Centre's public engagement programming: podcast interviewees are often drawn from previous contributors to the USAPP blog, and interviewees in our Extra Innings segments are frequently speakers from our public events and conference programmes. In 2022, in conjunction with a USAPP blog series, The Ballpark will be releasing a podcast series that takes a close look at climate change and climate change policies in the US.

Programmes to improve the student experience at LSE have become an important part of the work of the Phelan US Centre.
