LEARN FROM CHINA?

If we make a comparison, the 2 first time a Civil Code, and this is judiciary systems are different. The Italian system has a great history derived from roman law, but its mechanisms lack of efficiency and needs modernisation, especially for business law case: in order to attract they became more investors, we require a judicial system practical, basing their work on that works and respects several parameters like disposition time and can see innovative courts that clearance rate, which are essential for this purpose.

China has a relatively young judiciary system and uses the case law method to resolve the lack of a robust law formation: thev need specialised judges.

I think that this solution can be wisely adapted to our system: decentralising some courts with a specific purpose, for business needs, can really help Italy to become more and developing entrepreneurial vocation of Country.

WHY LEARNING CHINESE LANGUAGE AND CULTURE IS **IMPORTANT IN BUSINESS?**

In China Guanxi describes the importance of building a strong relationship during business affairs, that is a cultural aspect that we can summarise in this phrase: on the base of your soul and capacity to let people trust you, I can understand if you are a good business partner or not.

I think that knowing mandarin language represents a significant vehicle to understand better this world and enter almost totally in its mechanism.

In some ways this approach can be useful for each new culture we deal with, the language is one of the best ways to start to live a complete experience in a country: many concepts can be said differently, and this difference can tell us very much about a culture.
