## Aims

Development of the system for planning and provision of social services at the regional level' is part of the measures envisaged to improve the skills of professionally employed carers, volunteers or family members in relation to operational objective 5 'Development and modernization of long-term care and ensuring equal opportunities for access to social services for adults of the 'National Concept for Promoting Active Aging in Bulgaria' (2012–2030); An activity was launched in October 2014 entitled 'Analysis of the status of specialized	institutions for elderly people – people with mental disorders, with physical disabilities and sensory disturbances; for people with dementia; for people with mental retardation and the elderly'. The main objectives of the activity are to support the process of deinstitutionalization of care for the elderly and the implementation of the objectives and measures envisaged in the National Strategy for Long-term Care objectives as well as providing an overview of the status of specialized institutions for adults with disabilities and the elderly in Bulgaria.

## Implementation

Regional coordinators perform on-site visits by monitoring and collecting information on social services as well as participate in the preparation of the annual monitoring reports in relation to the implementation of regional strategies for social services development. In 2014, various trainings were conducted: training of trainers for the management and provision of social services and supervision; training of representatives of the target groups for monitoring and evaluating the implementation of policies and strategies for development of social services, risk	assessment and implementation of supervision and crisis interventions as well as control of the quality of provision of social services; training of employees of municipal administrations aiming at management, quality control and procurement of the management of social services; training of social service providers for management and quality provision of services.
	Development of a methodology for evaluation, including evaluation cards necessary for the study of all boarding-house type homes for the elderly.

Elderly people, people with disabilities, vulnerable groups living in poverty, home helpers, volunteers, carers.
