Summary of Professional Experience

Alina has over twenty years of experience in climate change policy and international development. Currently she is a Distinguished Policy Fellow and Lead for Governance and Legislation at the Grantham Research Institute on Climate Change at the London School of Economics and Political Science and Senior Research Fellow at Royal Elcano Institute. Her most recent work focuses on the analysis of experiences with climate change governance and legislation around the world and capacity building and advisory to governments and parliaments on the design and implementation of climate and energy laws.

Prior to joining the LSE in 2013, as a Global Director for Climate Change and Carbon at KPMG, Alina led strategic global initiatives on sustainable development, thought leadership and new product development. She provided advisory around low carbon and climate resilient strategies and mobilization of finance in developing countries. Alina also facilitated global collaboration and knowledge sharing across over 150 country advisory teams and represented KPMG in external associations.

In 2008-2010 working for First Climate she was a Member of the Executive Committee of the Project Developer Forum, an association of the developers of mitigation projects in developing countries. She also advised developing country governments on climate policies. In 2005-2008 at the UNFCCC secretariat in Bonn Alina supported the international negotiations on post-2012 regime (i.e. the Bali Action Plan) and worked with the Executive Secretary on interagency cooperation and strategic initiatives.

Alina has extensive experience in providing advisory and capacity building services to governments, international organizations and private sector on climate change strategies, legislation and public-private partnerships. Currently she consults the UN, World Bank, and other organisations. In 2019-2020 she served on the UN Secretary-General's Task Force on Climate Finance. Alina has developed and carried out trainings and facilitated multi-stakeholder dialogues on climate change in several developing countries and at the regional level in Latin America and Caribbean, Eastern Europe and in Asia. Alina is on the UNDP roster of experts on low carbon development strategies.

With over 50 publications, Alina is a frequent speaker at the high-profile international events, including most recently at the international Inter-Parliamentary Summits; the Parliaments of Spain, Portugal, UK, Peru and Morocco and the UNFCCC events.
