## **Enrolment**

#### Pre-Enrolment online

- The email inviting you to pre-enrol is sent out on a rolling basis (typically within 2 weeks of your scheduled campus enrolment date).
- This will give you access to LSE microsite, Moodle, LSE e-mail set-up, choose courses, etc.

#### Campus Enrolment

- PGT Law Registration Date: Friday 19 September
- Students arriving after that date will be able to book an appointment to complete their registration: <a href="https://info.lse.ac.uk/current-students/your-first-weeks/late-arrivals">https://info.lse.ac.uk/current-students/your-first-weeks/late-arrivals</a>
- Campus enrolment is where we check your identity documents (passport, visa etc.) and verify your eligibility to study in the UK at LSE. Once you have campus enrolled, you will be issued with your LSE ID Card.
- Students cannot attend classes until this has been completed.



#### Student Representatives/Elections


The LLM Student Academic Representatives are an elected group of LLM students, whose role is to represent the postgraduate student body on the Law School Staff Student Liaison Committee (SSLC).

There will be six roles available, all with equal footing.

Elections for these roles will take place once term is underway and will be run by the LSE Student Union. We will circulate information to you in Welcome Week.

#### Key Tasks and Responsibilities

- Undertake induction and training for Student Academic Representatives through the Student's Union.
- Attending termly SSLC meetings, gathering cohort feedback to inform agenda items for discussion.
- One representative to attend the <u>School Consultative Forum</u> as LLM rep (approx. three per year).





# Non-Degree Language Courses & Grants

All LLM students are eligible for £150 towards the fee to study a language course with LSE Language Centre.

Registration for these courses opens 22 September 2025.

When you register for these courses, your fee will be adjusted and the discount applied at billing stage.

Most courses commence in week 4 of Autumn Term, from Monday 20 October 2025.

Languages available are:

- Arabic
- French
- German
- Italian
- Japanese
- Korean
- Mandarin
- Russian
- Spanish

These courses do not count towards your LLM requirements.

## LLM Alumni Panel: Wednesday 1 October 6pm


Hear from some of the LLM Alumni about their study experiences and career journeys, with opportunity for questions and the chance to network after the panel.


