### Recently announced

Innovative approaches for investigating how children understand risk in new media: offers guidance on research methods, ethics and design, with worked examples of innovative qualitative studies from EU Kids Online.

**Zero to eight: young children and their internet use** reviews 70+ studies on the benefits and risks of the digital age for very young children. Includes policy and research recommendations.

**Our consultation response** to the European Commission's green paper, "Preparing for a Fully Converged Audiovisual World: Growth, Creation and Values"

**Report on classification of countries** groups countries into four groups to capture differences across Europe in online opportunities, incidence of online risk and harm, and types of parental mediation. Includes 25 country portraits and recommendations.

**In their own words: what bothers children online?** Reports the views of nearly 10,000 children who told us what upsets them and their friends online. Pornography and violent/gory content top children's concerns, especially on video-sharing sites.

**European evidence database**, fully searchable, with information on 1200 recent studies in Europe on children's use of internet and mobile technologies; with summaries of 500 key studies. Accompanied by a **report** of research trends and **FAQs** on methods.
