"Post-Erdogan imaginaries" - panel for the Council for European Studies (CES) 2022 conference, Lisbon, 29 June-1 July

Dear friends,

Kumru F. Toktamis (Pratt Institute, US) and I (Isabel David, University of Lisbon, Portugal) are hoping to put together a closed panel for next year's CES conference in Lisbon on the following theme:

Post-Erdogan imaginaries

A vision heralding the end of the AKP (Justice and Development Party) regime is hardly available in the horizon of the political opposition in Turkey. This regime, as authoritarianisms elsewhere, has been leaving its mark on society and politics in Turkey since 2002, yet the opportunities of change are implicit within the dynamism of the regime itself. Our panel aims to explore international and domestic dynamics of the AKP regime that will help researchers to envision possibilities of political and social change and identify patterns of resistance, such as Kurdish politics, ecologists, women's movements, the LGBTQ and labour, in order to produce a comprehensive framework. Are there dynamic social, cultural and political forces that anticipate a more progressive or more repressive post-AKP regime in Turkey? How do they negotiate a past and a future along the geographies of the Turkish Republic? Are these indeed forces of democratic participation or diverse forms of conservatism? How do collective actions and social movements operate at such times of transformation? We argue that only such framework that moves from theory to policies and practices can identify trajectories of continuity and change, and comparatively inform researchers of rising authoritarianisms and modes of resistance elsewhere in the world.
