# Call for Papers: the 4th LSE-Fudan Annual Conference on Global Public Policy

## AI and Technology Governance

Papers addressing regulatory frameworks, ethical guidelines, and governance mechanisms for AI deployment in public sectors. Topics include AI accountability, algorithmic transparency, cross-border data governance, digital rights, and international cooperation on AI standards.

## **Environmental Policy and Climate Technology**

Research on how AI and digital technologies can support environmental sustainability, climate adaptation, and green transitions. We seek papers on AI for climate modeling, smart city initiatives, environmental monitoring systems, and technology-enabled circular economy policies.

## **Industrial Policy and Digital Transformation**

Contributions examining how governments can foster innovation while managing the socioeconomic impacts of digital transformation. Topics include AI industrial strategies, public-private partnerships in technology development, digital trade policies, and the role of state capacity in digital governance.

We invite researchers to submit abstracts of no more than 300 words outlining their proposed papers or panel discussions. Please include the following information:

- A brief biography (100 words) for each author
