Congratulations to our latest MSc City Design and Social Science their graduates who received degrees December. in and especially to Heather Zaccaro, awarded the Cities Prize for Academic Achievement 2016, and Darren Gill, awarded the Cities Prize for Outstanding Contribution 2016 in recognition of his contribution to the work and culture of the programme.

This year the focus of the City Design Research Studio, which is at the heart of the MSc programme, huge Thamesmead is the bordering development the Thames in the south-east of London Thamesmead falls between the London Boroughs of Greenwich and Bexley and is home to 40,000 people. Naveed Ahmed (Class of 2008) is Principal Strategy Planner for Surface Strategy and Planning at Transport for London. He reports: "Through TfL's Internal Surface Innovation Fund I've installed a green roof bus shelter as part of an urban greening project. The site was selected for the new green #Buzzstop so that the roof provides an attractive pocket park visible at eye level as people exit Baker Street station, from surrounding buildings and from the top decks of passing buses. In Sprina. wildflowers will blossom creating a much more visible presence.

"The #Buzzstop provides a new habitat for pollinators such as solitary bees and butterflies creating a link in the green corridor between Hyde Park and Regents Park, supporting London's <u>B line</u> initiative. Additionally, it supports sustainable urban drainage by cleverly channelling rainwater. It ties in to the Mayor's manifesto Teaching 2016-17:

Dr **Corinna Dean** (PhD Cities 2014) has taken up a position as Lecturer in the Architecture Department of the University of Westminster. She will be carrying out a residency in the ROOM gallery on the Isle of Sheppey, Kent in June, as part of the Sheerness Dockyard Preservation Trust,

exploring ideas under the archive and research programme ARCA, Archive for Rural Contemporary Architecture which she established in 2015 <u>www.arca-projects.com</u>

Sofia Garcia (2014) will present her current research on land markets, property rights and housing affordability in Lima at the 18th Annual World Bank Conference on Land and Poverty to be held in Washington D.C. in March this year. Her paper is entitled: "From Housing to Titling: a critique of the Peruvian approach to informality housina and а contribution to a new land and housing policy".

explores Peruvian Sofia the practice of land titling, which was massively deployed during the 1990s under the neoliberalizing project of former president Alberto Fujimori, with the financial aid of the World Bank and following Hernando De Soto's advice on property theory. She analyzes how the formal legalization of ownership through the delivery of individual freehold titles functioned as a form neoliberal populism which of expanded the gap between the formal housing market and the poor's capacities to access it; and undermined the State's own financial capacities for investment in affordable serviced land and public housing.

The work of Re-constructing Sarajevo, the publication which many of the MSc City Design students 2013-14 contributed to, and edited by Sofia Garcia and Bronwyn Kotzen, will form part of the Sarajevo Now conference lineup on invitation from Professor Alfredo Brillembourg and Haris Piplas - curator of Sarajevo Now, a pavilion at the Venice Biennale and part of Urban Think Tank at ETH, http://www.reactivate-Zurich: sarajevo.com/#team. Serena Girani presented the publication on Friday 23 September 2016, as an LSE alumna and representative of the Reconstructing Cities project.

Juan Sebastian Lama (2014), is making news in San Francisco with Hitmap, a Smart Cities start-up based on a sales prediction algorithm (MyHitmap.com).

Hitmap is an online service where retailers can find new business locations and predict sales for each new store. The core is an algorithm that statistically condenses hundreds of urban variables (e.g. median income, distance to public transport, closeness to

competitors) into a sales-prediction score specific to each business.

In its three years of research development and operations, Hitmap has shown its full potential by helping Off The Grid - the famous food-truck markets in San Francisco, California - expand from 5 to 52 locations in two years, becoming the fastest-growing foodtruck company in the USA. But its potential doesn't end in retail, Hitmap GIS intelligence and easyto-use interface has also proved effective for cities transforming underdeveloped commercial areas. Lucrecia Montemayor (2008) has been named Deputy Director for Energy and Environment at Regional Plan Association (RPA), an urban research and advocacv non-for-profit based in New York City. Recently, she published a paper with Ellis Calvin on Identification and Classification of Urban Development Place Types for the New York Metropolitan Region, describing the process of creating a place typology for the New York Metropolitan Region for use in the upcoming regional plan A Region Transformed, which was presented in Seattle at the 1st International ACM SIGSPATIAL Workshop on Smart Cities and Urban Analytics.

As part of the planning process for RPA's fourth regional plan, RPA in collaboration with Guy Nordenson and Paul Lewis from Princeton University, is launching a design competition in late January for design strategies along four regional corridors. One is research into social housing for rent, focusing on the internal framework of Infonavit, with the intention of getting on foot a pilot project at the end of the year. The Honours List recognises people who have made achievements in public life and committed themselves to serving and helping Britain. Ricky Burdett's CBE is for services to urban planning and design.

Dr **Suzi Hall** is very pleased to be working within interdisciplinary teams on two new research projects. The *High Streets For All* project for the Greater London authority explores the social and economic value of London high streets. LSE Cities and We Made That have teamed up, and Suzi and **Julia King** are working with MSc City Design alumna **Melissa Meyer** (Class of 2013).

Suzi will also be joining Myria Georgiou from the Media and Communication Department at LSE to work on the *Resilient Communities, Resilient Cities? Digital makings of the city of refuge* project, funded by the IGA-Rockerfeller Grant.

The Royal Commission for the Exhibition of 1851 awards some 25 postgraduate Fellowships and Scholarships a year, for advanced study and research in science, engineering, the built environment and design. The biennale Design Fellowship this year has been awarded to Dr Julia King for her proposal to identify, design, and prototype interventions to address the problem of how to deliver sustainable sanitation solutions in context of disconnected the marginalized communities in Delhi, India. The intention is to work from the scale of the individual toilet all the way to micro treatment plants.

These plants offer the currently largely untapped ability to manage effluent and convert that to water for a community who are deprived of both. The method of research by live project (action based research) is proposed in order to gain a more hands-on perspective by actively participating rather than only observing; adding to emergent forms of architectural practice and research, particularly in contested and marginalized spaces, as the endeavour of a collaborative maker.
