

## Summer School Credit Transfer Guidance for EMFSS Students

**To transfer credit from Summer School to your EMFSS degree, you must have your course choice(s) approved by the LSE EMFSS Programme Management Team before attending by following these steps:**

1. Identify the Summer School [courses](#) you are interested in.
2. Read the credit transfer guidance below to see if the courses are suitable for your degree.
3. Complete the [EMFSS - Summer School notification form](#) to notify LSE of your course selection. *(A link to this form is also provided within the Summer School application form. There is no need to submit the form twice.)*
4. On receiving the form, LSE's EMFSS Programme Team will review your course selection and confirm if you are eligible to receive credit.
5. You should expect a response within five working days of submitting the form, after which you can complete and submit your Summer School application.

### **General guidance on rules for credit transfer:**

Before choosing your Summer School course(s), read the guidance below on the rules for EMFSS credit transfer. Rest assured that the EMFSS Programme Team will also review your course selections and confirm if they are eligible (see steps 3-5 above). If you select a course that is not eligible for credit, you will have the opportunity to change your course selection.

### **Your eligibility for credit transfer is based on:**

1. Which points you have left available on your EMFSS UoL degree structure;
2. Whether these points require 100, 200 or 300 level courses; and
3. Which EMFSS courses you have already taken or are required to take.

Please note: If you have already passed an EMFSS course on your degree structure, you cannot replace this with Summer School credit.

### **Before reviewing the credit transfer table below, note:**

- EMFSS degrees are made up of 12 points on the Standard Route and 9 points on the Graduate Route. Each point is worth 30 credits. Refer to [Appendix A of the EMFSS Regulations](#) to locate your programme structure.
- Each Summer School course is worth 15 EMFSS credits (i.e. equivalent to an EMFSS half course). You can transfer a maximum of 30 credits to your EMFSS degree by completing two Summer School courses.

- Due to the limited number of 15 credit EMFSS courses, **we recommend that students take two Summer School courses** (i.e. to earn 30 credits and fill one of the degree points).
- To earn credit, you must pass the Summer School course(s) with a Grade C or above.
- The Summer School course title and percentage grade will appear on your UoL record.
- Summer School do not offer resit opportunities.

### **Guidance on Summer School course selection:**

When using the course selection table on the next page, please note:

**1. It is not possible to take a Summer School course which overlaps significantly with an EMFSS course you have studied, or will study, as part of your degree.**

These are identified in the 'Exclusions' column in the table below (see pages 3-10).

*Example: If you have taken EMFSS course EC2066 Microeconomics, you cannot earn credit for Summer School course EC201 Intermediate Microeconomics due to the overlapping content.*

**2. The majority of students will place Summer School credit at an optional point of their degree.** Typically, this is point 12 (for Standard Route degrees).

*Example 1: Point 12 of the BSc Data Science and Business Analytics degree allows a student to take "Any course". To place credit at Point 12, a student could select any two Summer School courses (as long as they have not studied EMFSS courses listed in the 'Exclusions' column in the relevant row of the table below).*

*Example 2: Point 9 of the BSc Business and Management degree requires 'Any 300 level MN course'. There are no Summer School courses approved for 300 level MN, so Summer School credit cannot be placed at Point 11.*

**3. In a few instances, Summer School courses are considered as directly comparable to EMFSS courses and can be studied *in place of* the EMFSS course.** This applies even if it is a compulsory EMFSS course on your programme structure.

- Summer School course **ME116** is equivalent to EMFSS course **ST104A** Statistics 1
- Summer School course **ME117** is equivalent to EMFSS courses **ST104B** Statistics 2
- Summer School courses **ME315** and either **ME314** or **ME319** when taken together are equivalent to EMFSS course **ST3189** Machine Learning

- Summer School courses **AC101 and AC110** when taken together are equivalent to EMFSS course **AC1025** *Principles of Accounting*
- Summer School courses **EC101 and EC102** when taken together are equivalent to EMFSS course **EC1002** *Introduction to Economics*
- Summer School courses **IR105 and IR211** when taken together are equivalent to EMFSS course **IR2214** *Foreign Policy Analysis*
- Summer School courses **IR201 and one 300-level course** (in any subject area), when taken together, are equivalent to the EMFSS course **IR3207** *Power Shift in International Relations*

*Example: A student could take Summer School courses AC101 and AC110 in place of EMFSS course AC1025. (Note: this is only possible if the student has not taken AC1025).*
