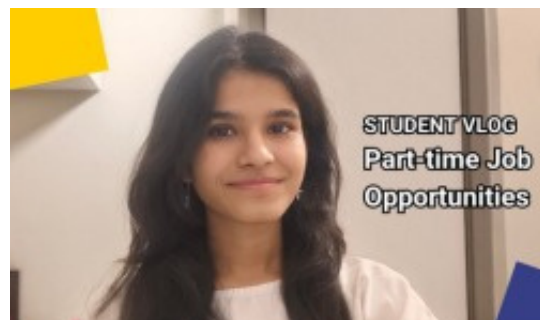

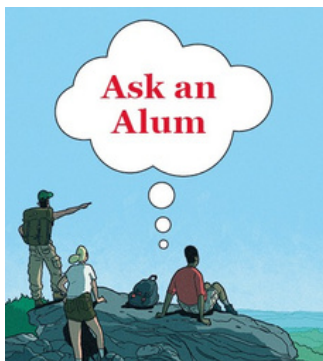

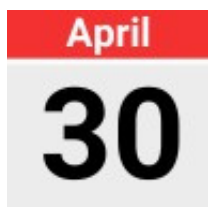


Ask an Alum is now available for offer holders!
