Rationale

This section should also include the key research questions or arts and impact objectives of the project.

Programme of Work

Describe the work to be undertaken in the project. This section provides more detail on the purpose of the project by situating it in relation to previous work on similar themes. What is novel or timely about the project? How does it respond to pressing issues of gender injustice and insecurity? For research-focused projects, provide details on existing scholarship, proposed methods and contribution to new knowledge. For arts and impact-focused projects, provide details on the approach to engaging relevant communities and stakeholders, previous attempts to achieve similar results, and contribution to raising awareness or communicating knowledge.

Outputs

Describe the outputs of the project. Outputs are the products of project activities and include, but are not limited to, peer reviewed academic publications, policy briefs, datasets, reports, exhibits, short films, blog posts, workshops, community engagement sessions, events with policy-makers and practitioners, conference presentations, training programmes and social media activity.

Fit with Hub

Describe how the proposed project fits with overall Hub objectives and complements existing Hub projects. This section should articulate both the thematic fit with Hub research and impact and the geographical fit with Hub countries of focus.

Partnerships

Describe the project's strategy to enhance and build meaningful and lasting equitable partnerships of mutual benefit with researchers and other partners, including how they have been engaged to date in the design of the project. If the project includes activities building the capability or capacity of project personnel or project partners, this should also be explained here.

No more than 500 words

Capacity and Capability of the Team

Describe the project team. This section should give details on the expertise and contribution of named researchers or project leads. The lead researchers or applicants should be the Co-Investigators named above, but the contribution of any other personnel should also be detailed. Where the project requires hiring new researchers or project personnel, the contribution of the role to realising project aims should be detailed. The anticipated FTE time commitment of Hub Co-Investigators and existing Hub partners must be included as evidence of capacity to deliver a successful project.

Justification of Resources

All resources requested (directly incurred, directly allocated and exceptions, including co-investigator time) must be fully justified. Explain how the costs contribute to the achievement of project objectives.

Safeguarding and Covid-Preparedness

Describe how safeguarding risks have been considered in the project design, with details on anticipating, mitigating and addressing potential harms. Applicants may wish to consult UKCDR guidance to understand more about safeguarding as distinct from research ethics (<https://www.ukcdr.org.uk/resource/guidance-on-safeguarding-in-international-development-research/>). This section should also explain how risks related to the Covid pandemic have been considered and addressed, including how the project can respond flexibly to future local outbreaks or lockdowns without sacrificing project outcomes.

Organisation Contributions

Describe the support given by organisations involved in the project. Research organisations will usually be expected to provide some in-kind contribution to demonstrate their commitment to the

project. Contributions listed here should correspond to what is detailed in the letters of support from research organisations and project partners.
